## MEAL ENTERTAINMENT

### *What you can't package*

- Purchase of general household food and drink (i.e. groceries)
- Purchase of alcohol to be consumed at home
- Tickets to movies or sporting and cultural events
- Services such as mini-bar, room service, laundry, in-house movies, and waiter hire
- Takeaway, home delivery, drive through meals or bottle shop purchases
- Coffee, coffee & cake (morning tea), drinks only, bottle shop purchases (refreshments are not meals)
- Food consumed in-flight
- Alcoholic drinks that are not purchased in conjunction with a meal

- Pre-purchased restaurant vouchers
- Entertainment in the form of cabarets, musicals, concerts, movies, theatre, sporting events, gambling or other similar forms of entertainment.
- Flights and other travel expenses, including parking
- Dry cleaning.
- Hire of a DJ, jukebox, band or other ancillary entertainment provided with the food and beverages.
- Accommodation and venue hire expenses incurred while travelling for work related purposes.
